<i>Language of interviews</i>	Spanish

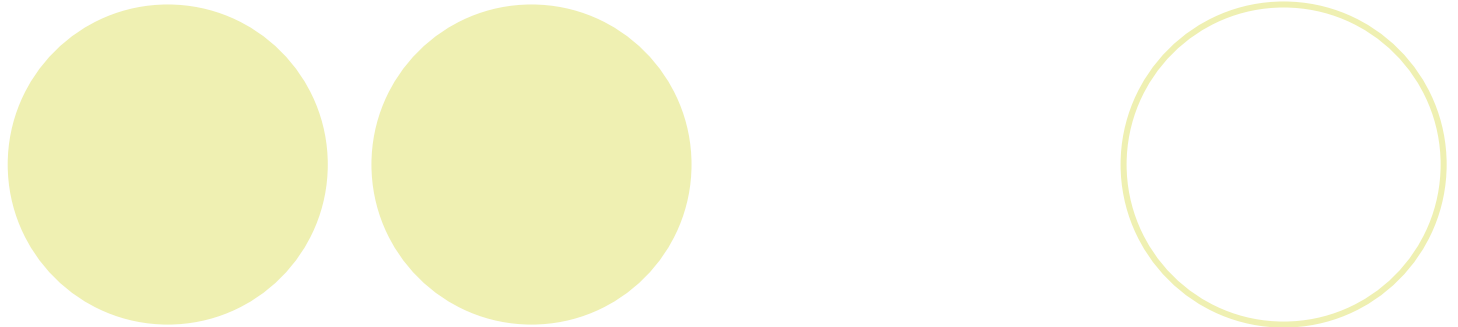
Sponsoring Foundations

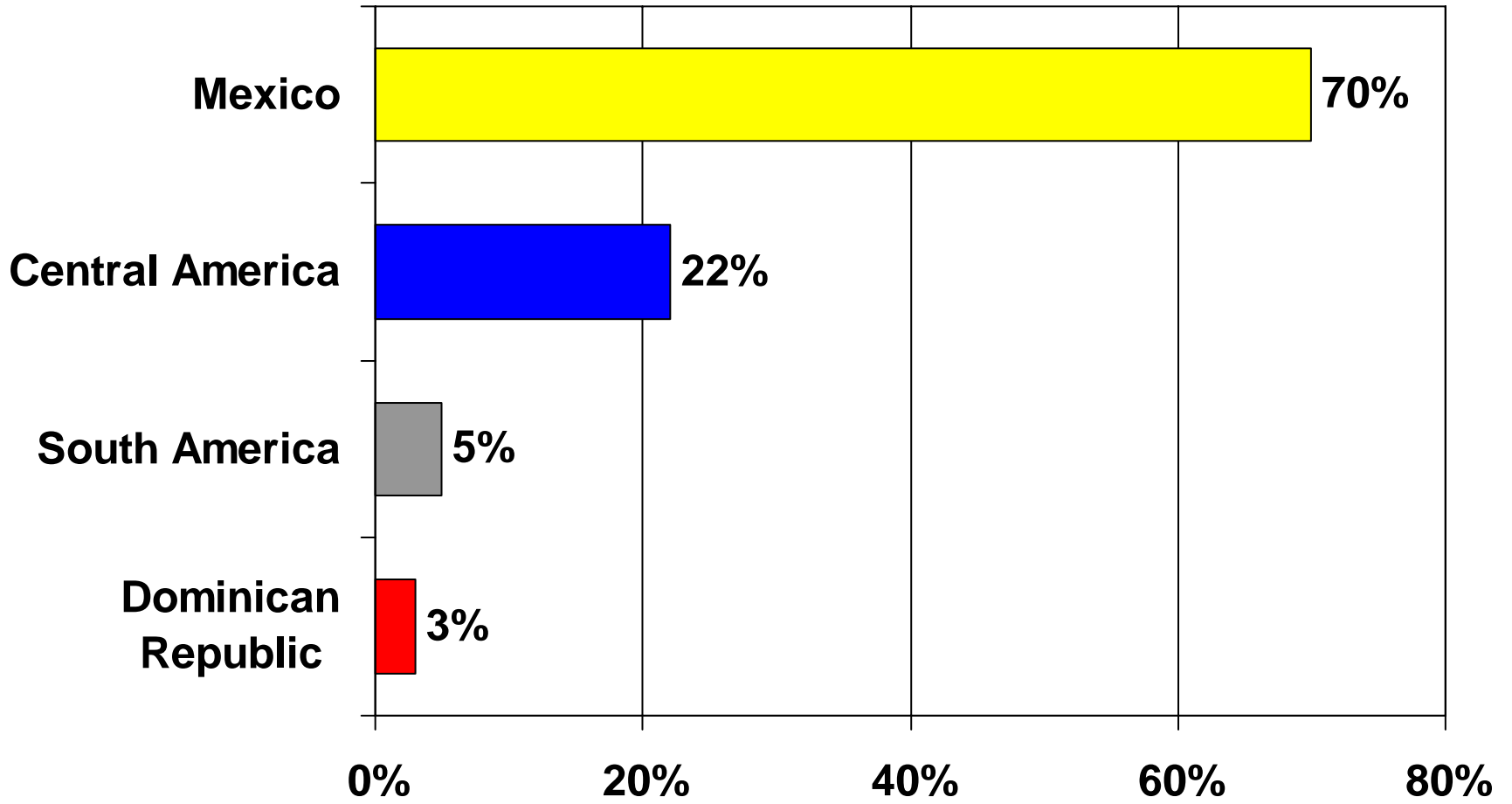
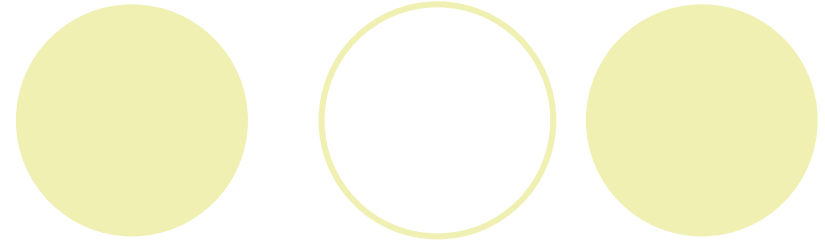
Question to Identify the Undocumented

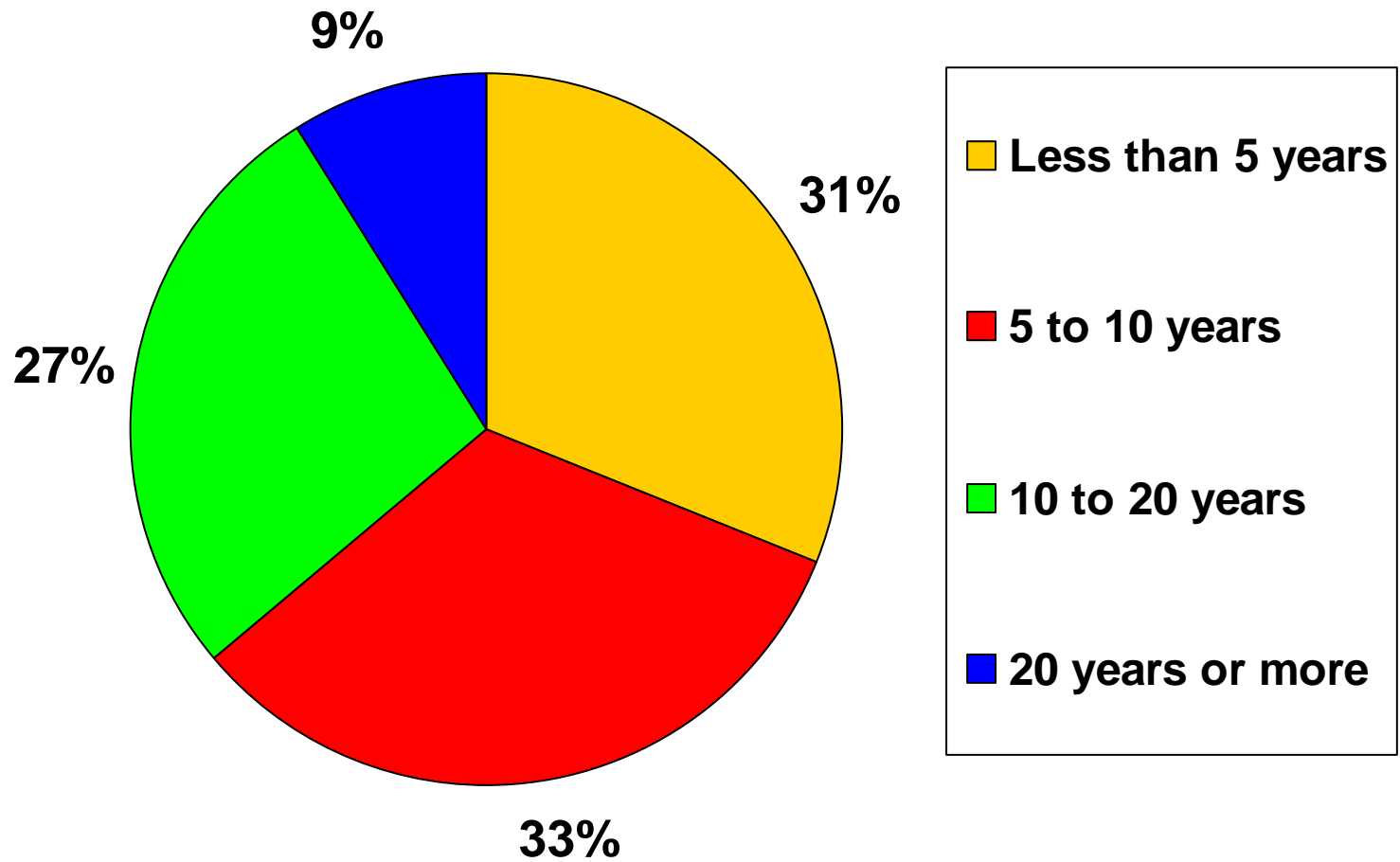
Demographics of Undocumented Latin American Immigrants in the United States



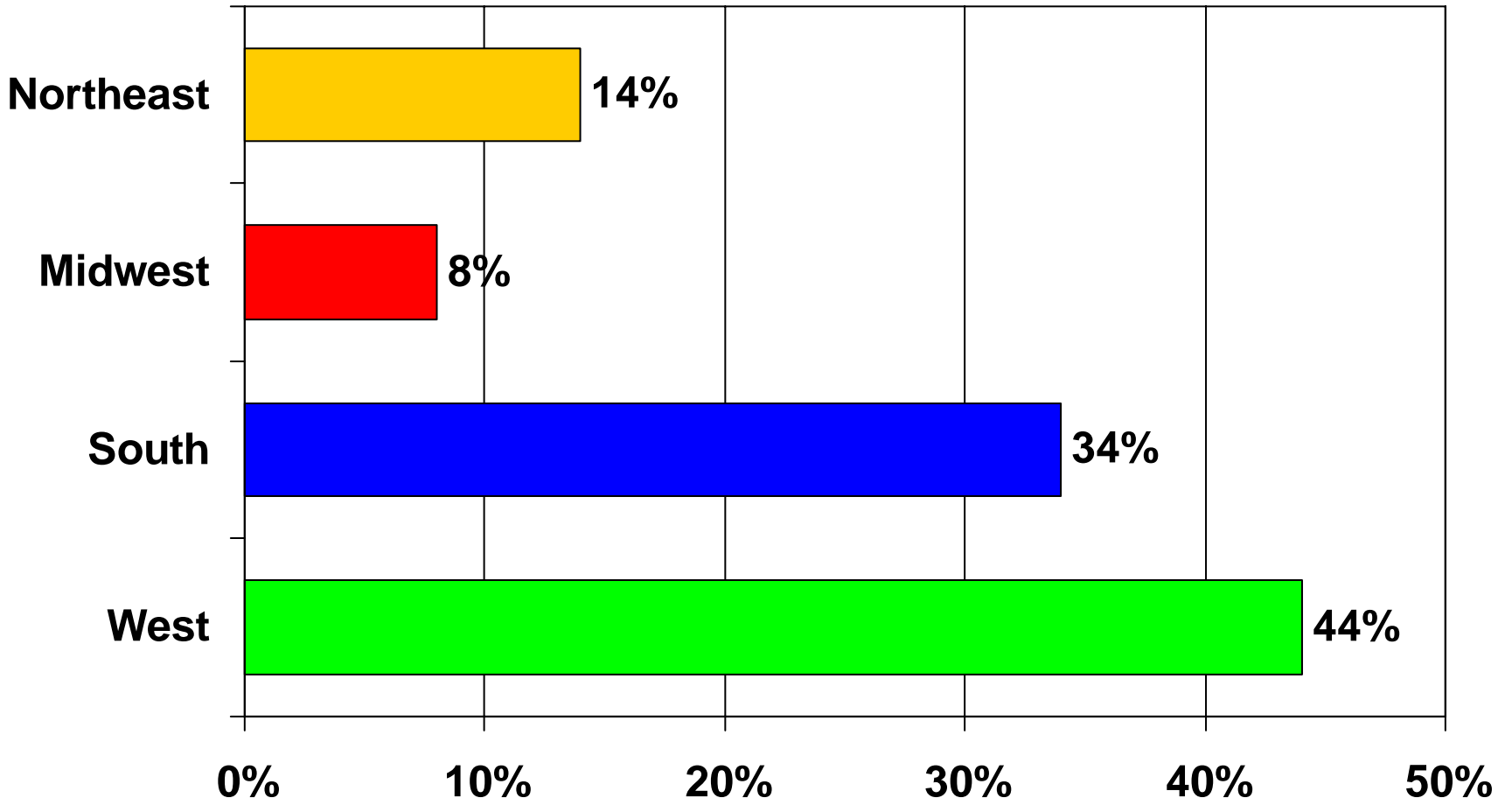
Country of Birth



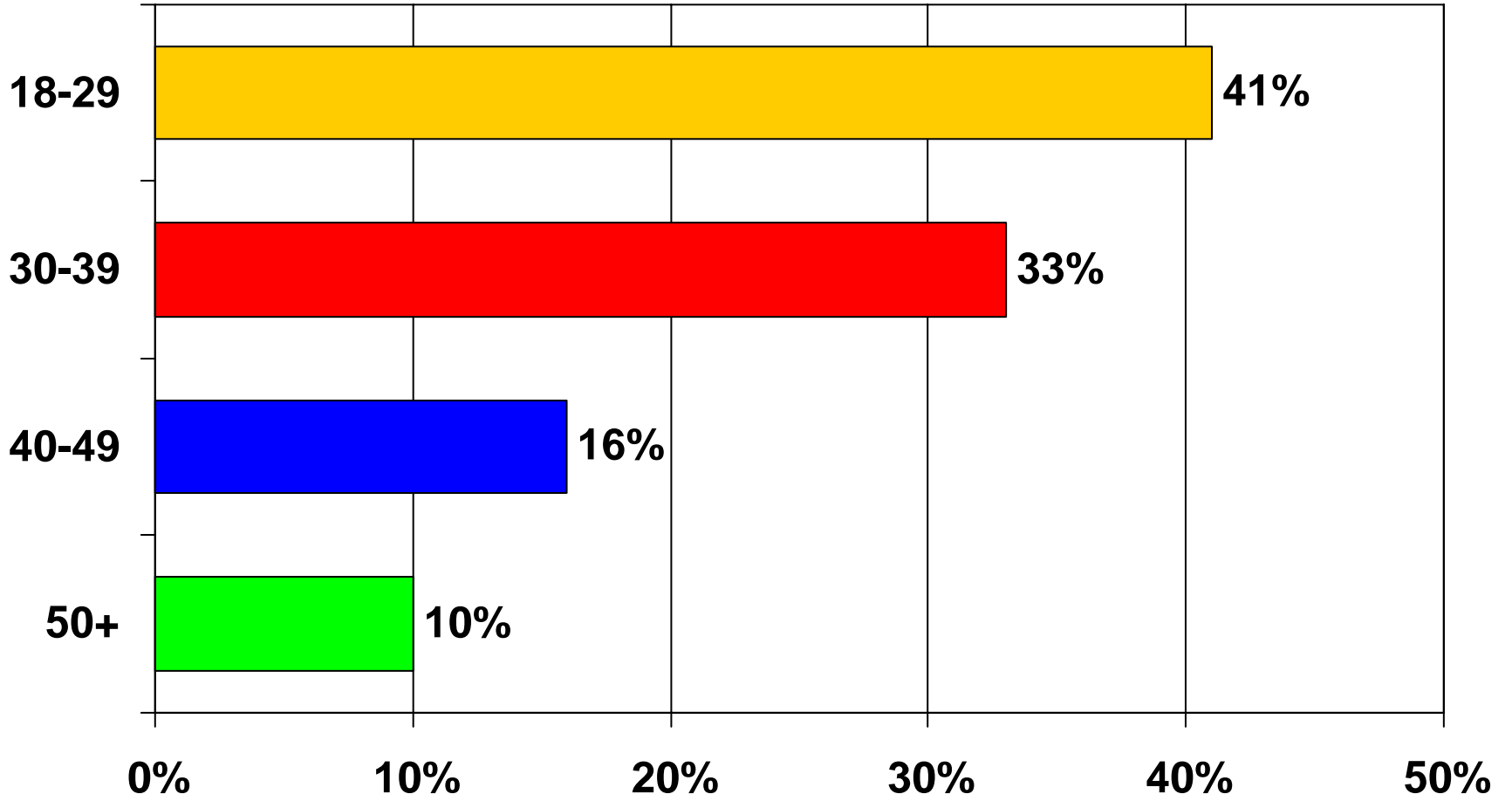
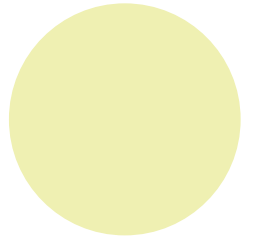
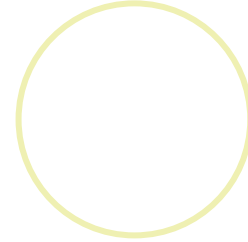
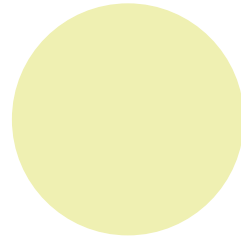
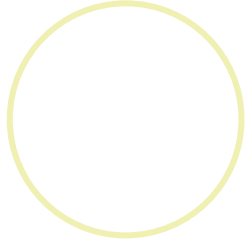
How long have you lived in the United States?



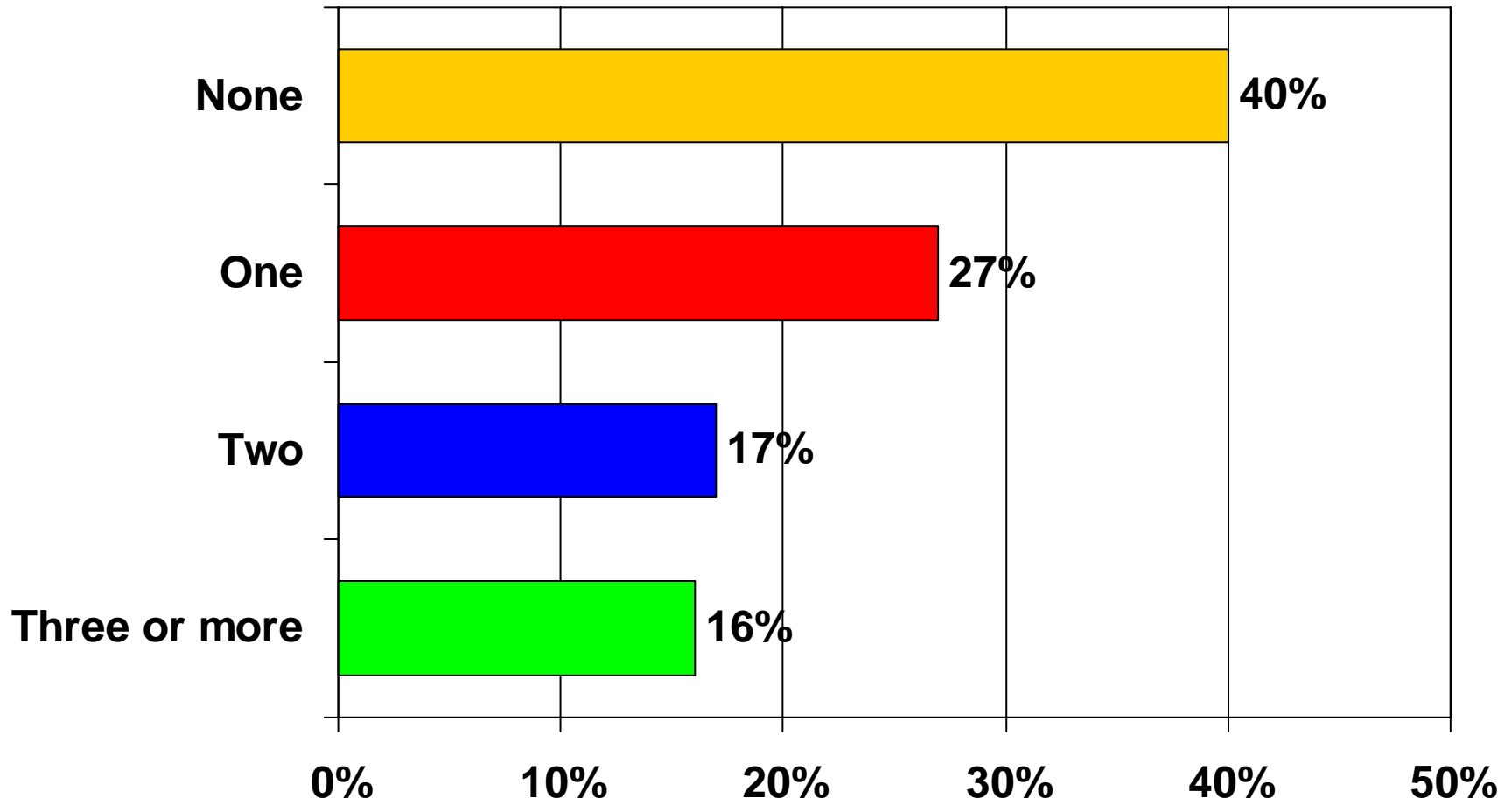

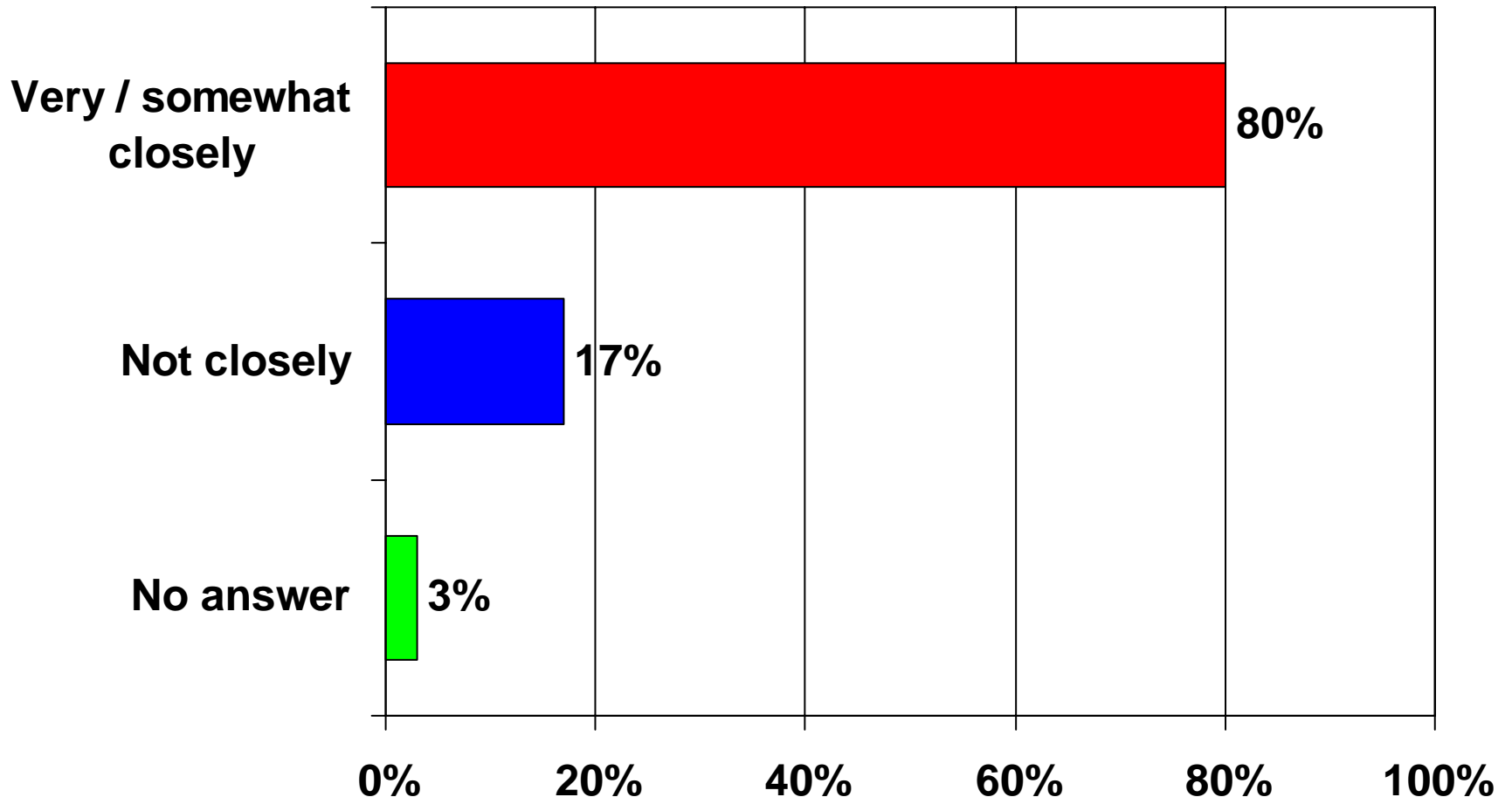


Number of Dependents

Congress is currently having a debate about the immigration policy of the United States. How closely have you been following this debate?



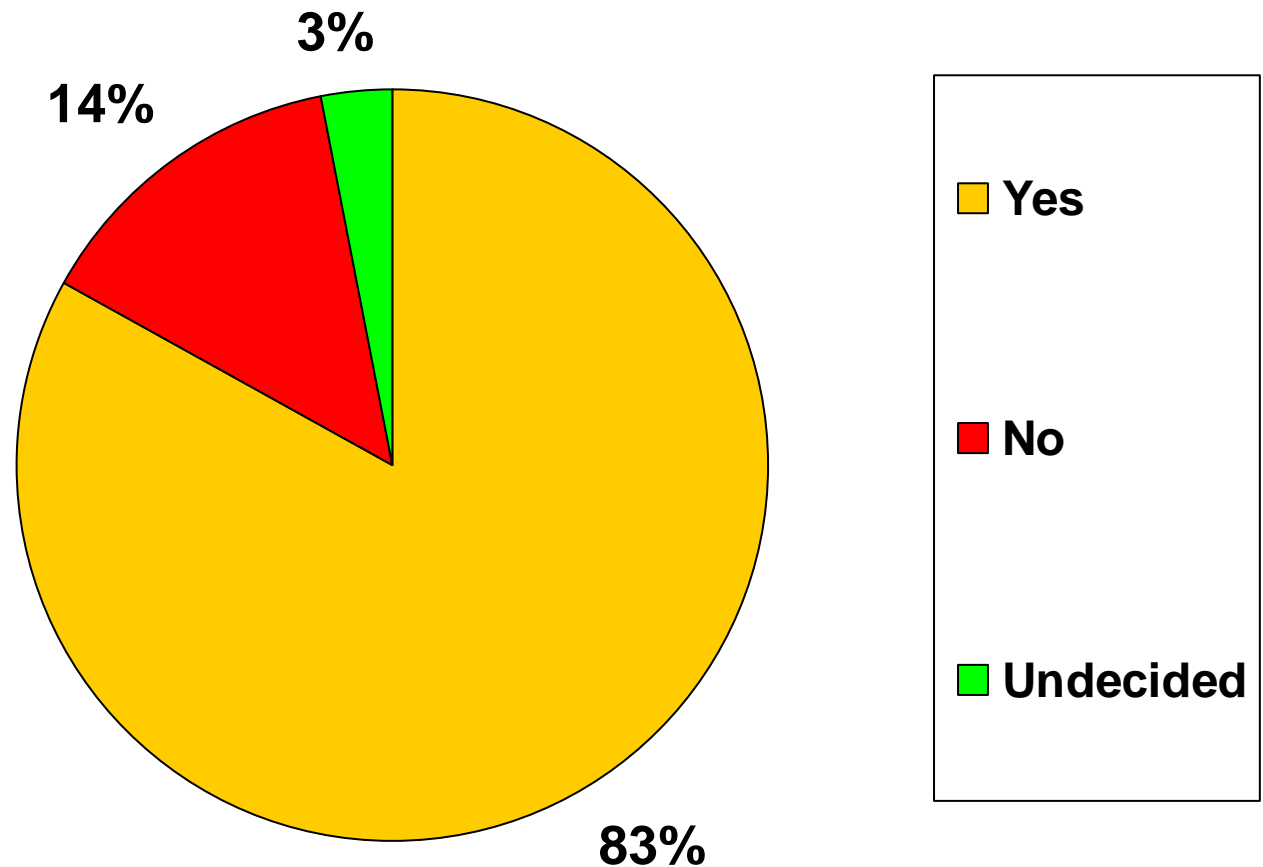


The New “Z” Work Visa

“Z” Work Visa Question

- The United States Congress is currently considering a new law that would allow undocumented immigrants to apply for a new visa. The head of the family would have to pay \$3,000 in fines and fees and an additional \$2,000 in fines and fees for each undocumented member of the family. They would have to show that they have a work record and pass a criminal background check. Those that qualify could then work and live in the United States legally. They would also be able to travel between the United States and their home country without problems. They could renew this visa every four years with a payment of \$1,500. If the Congress approved this new visa, would you apply for it or would it be easier for you to remain undocumented?

Would you apply for this new visa so that you could live and work in the United States legally or would it be easier to remain undocumented?



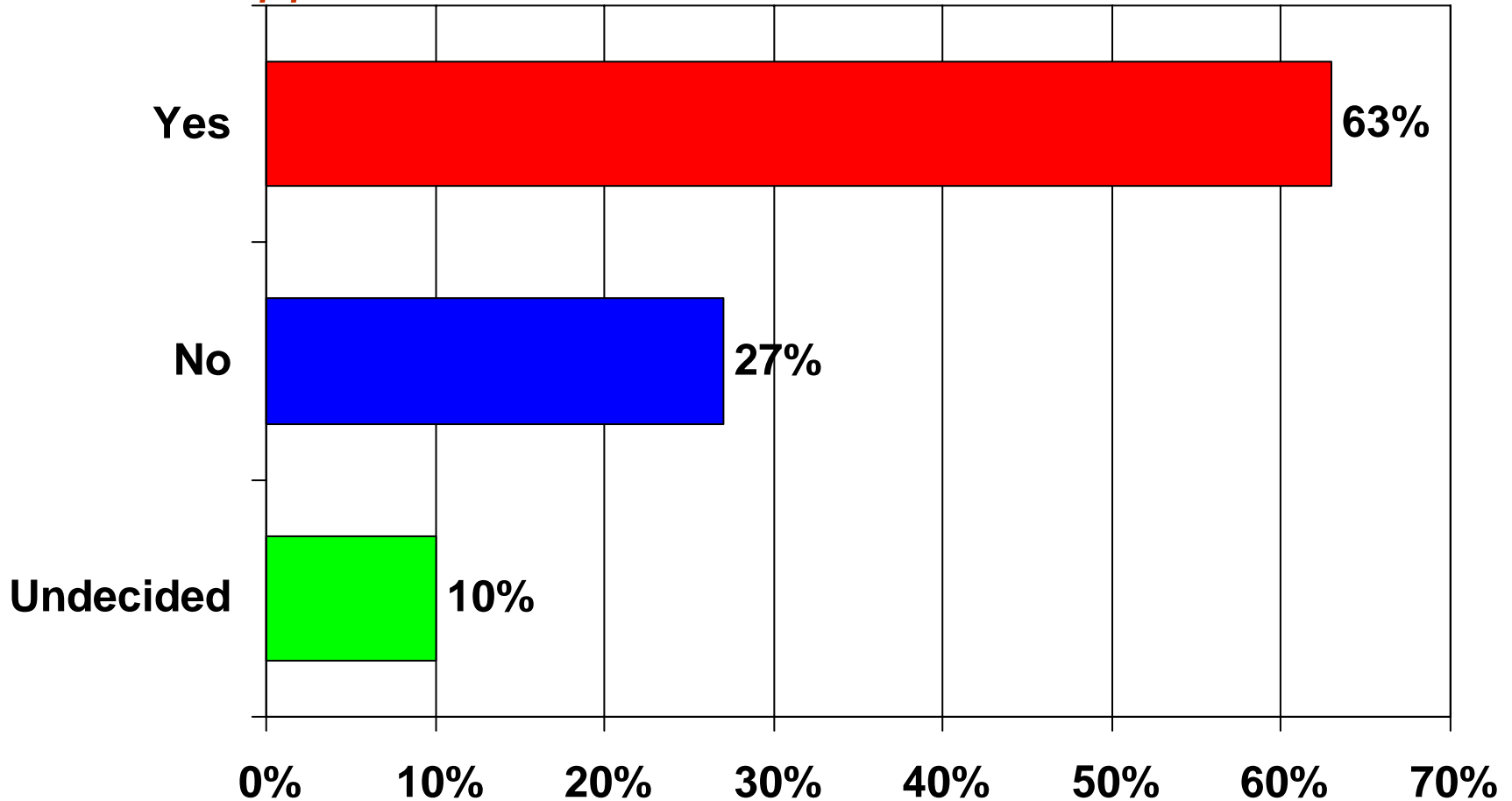
Requirements for “Z” Visa

“Yes” answers only

Be fingerprinted and agree to a criminal background check	94%
Be able to show that you have a work record in the United States	89%
Register at a government office and admit that you were in the United States illegally	85%
Pay \$3,000 in fines and fees for the head of the family and an additional \$2,000 for each undocumented member of your family	83%

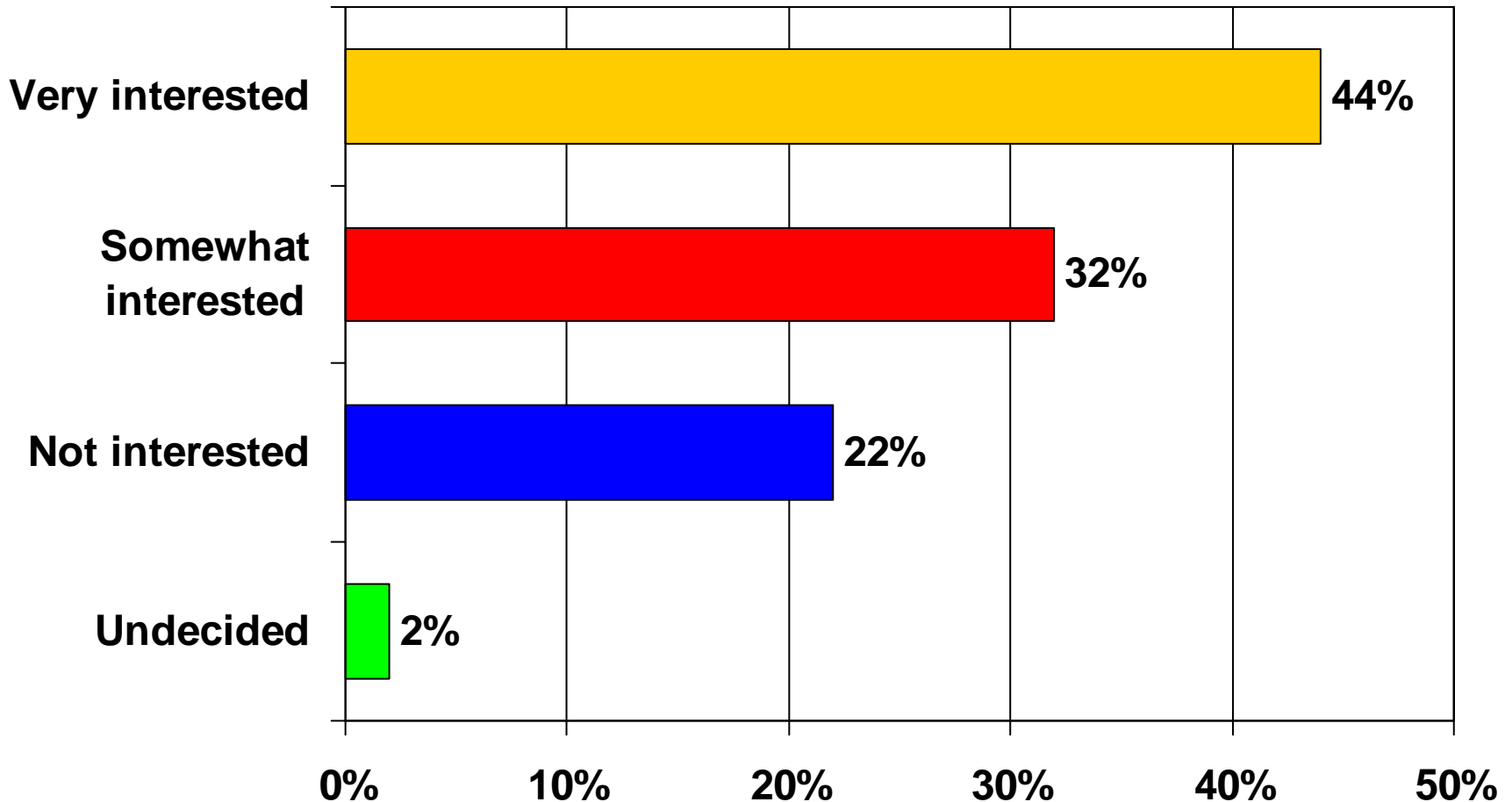




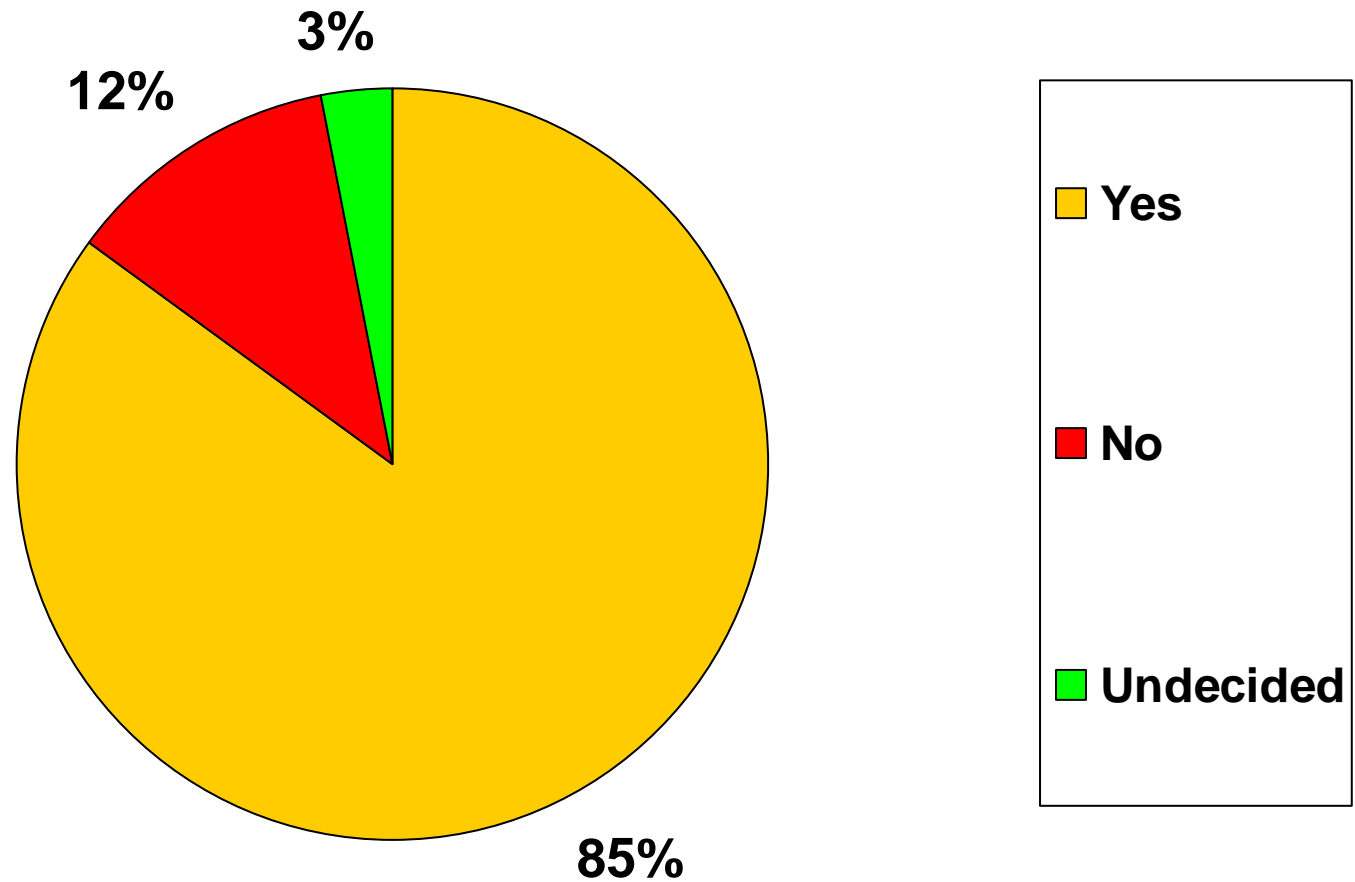
“Green Card” and Citizenship

How interested would you be in getting a “green card” and eventually becoming a citizen of the United States if this new law is approved?

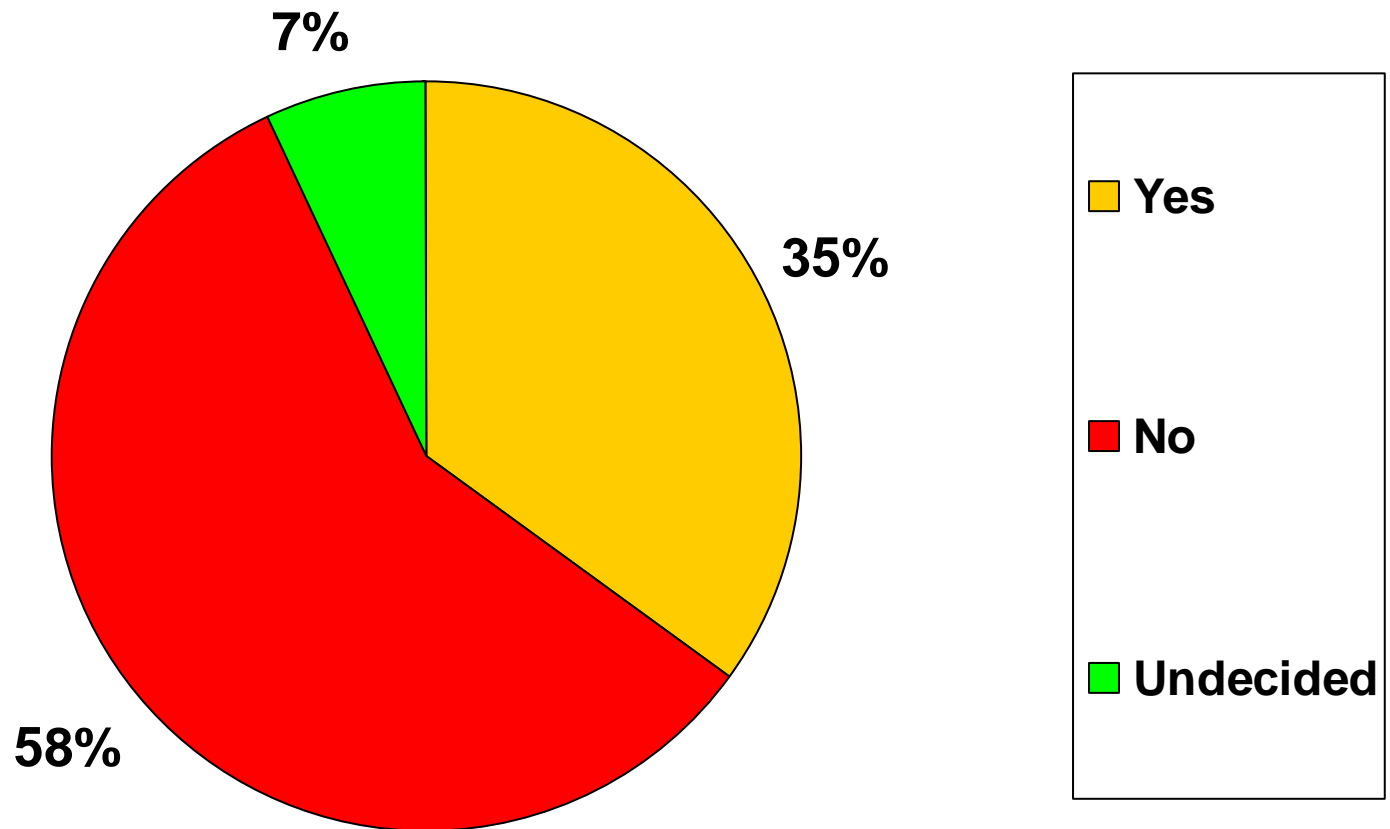

If you were guaranteed that you could return to the United States without a problem, would you be willing to return to your home country for a short period of time to complete an application for a “green card” at the U.S. consulate?

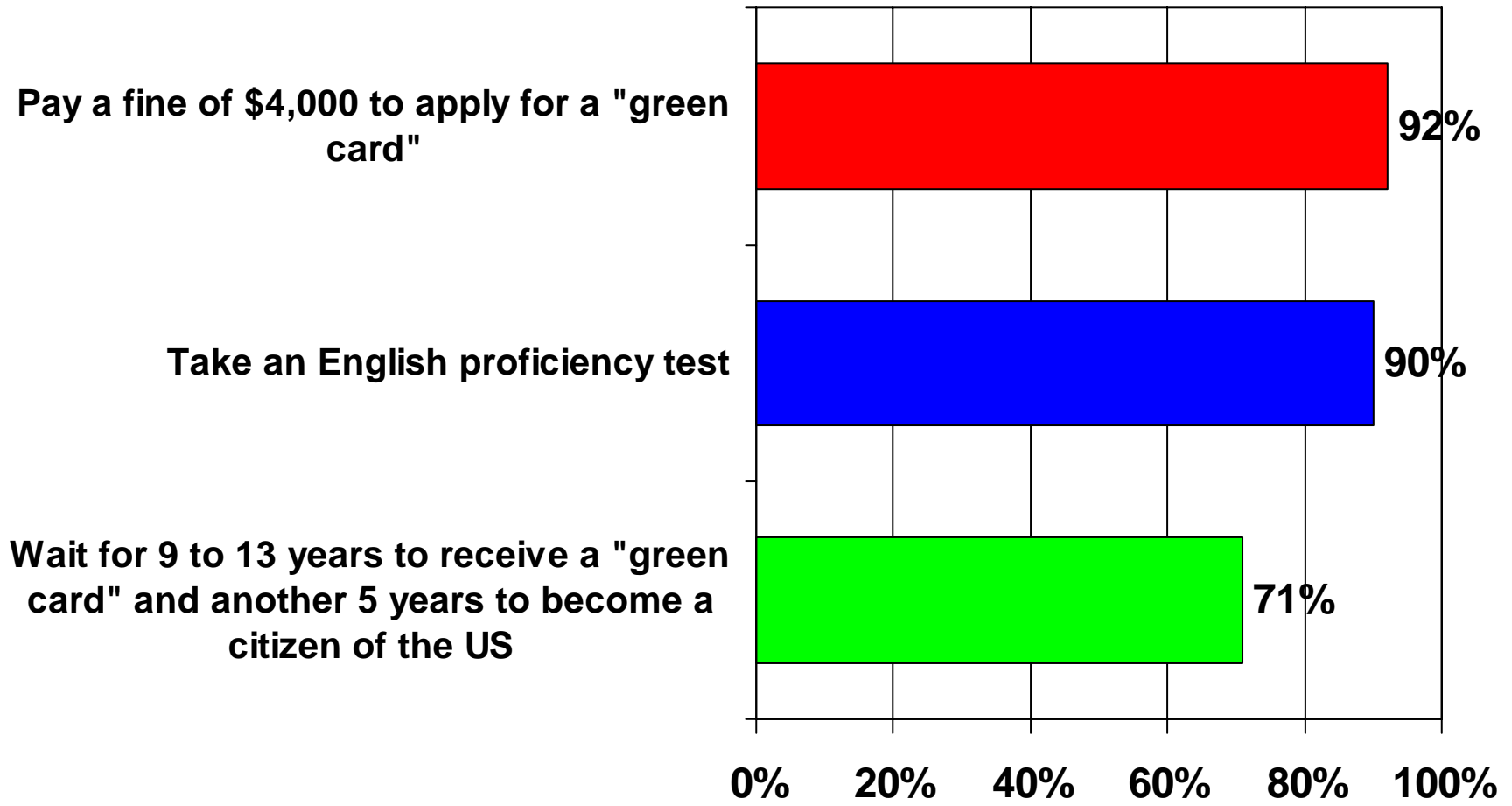


If you were not guaranteed that you could return to the United States, would you be willing to return to your home country for a short period of time to complete an application for a “green card” at the U.S. consulate?

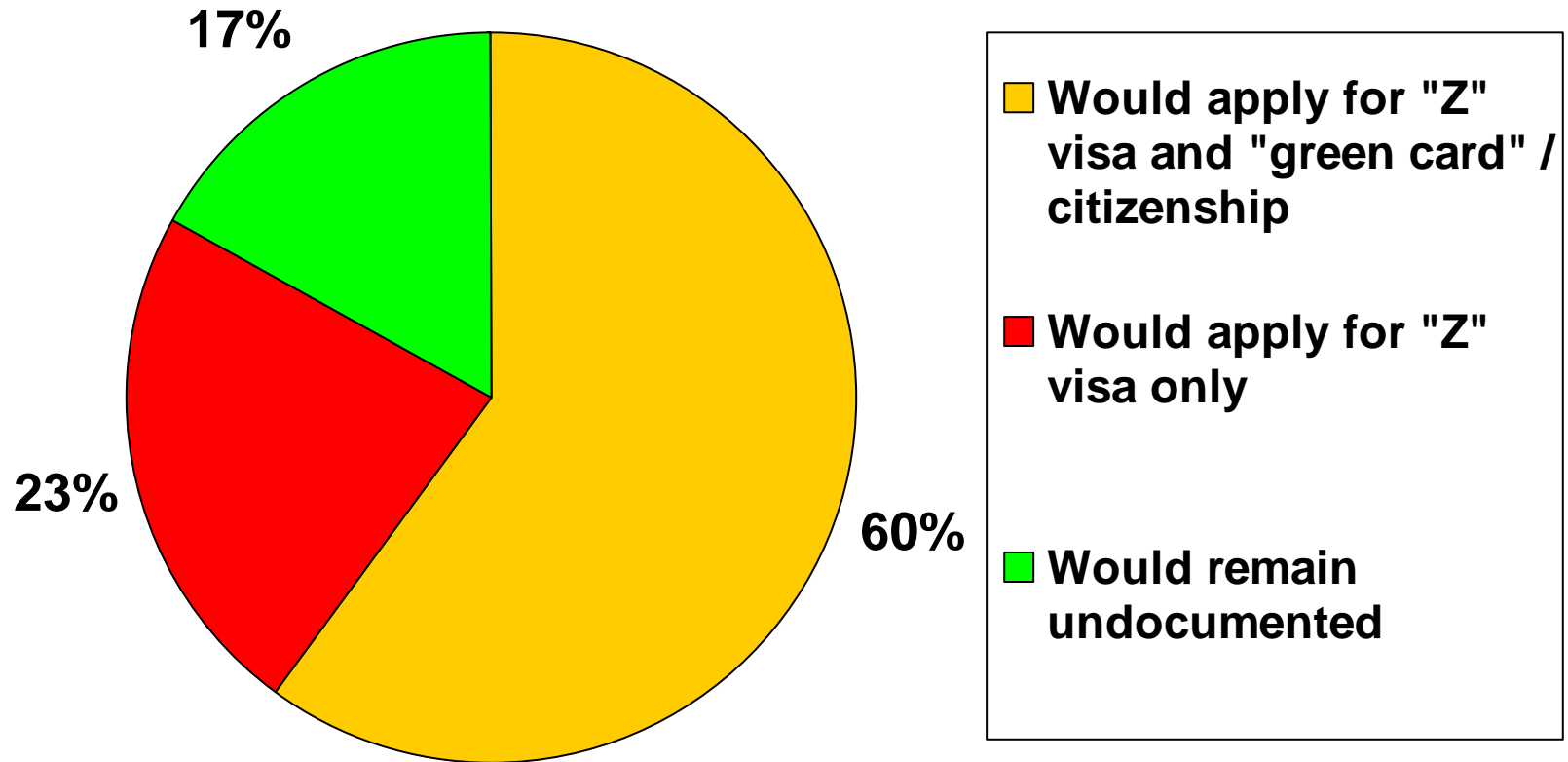

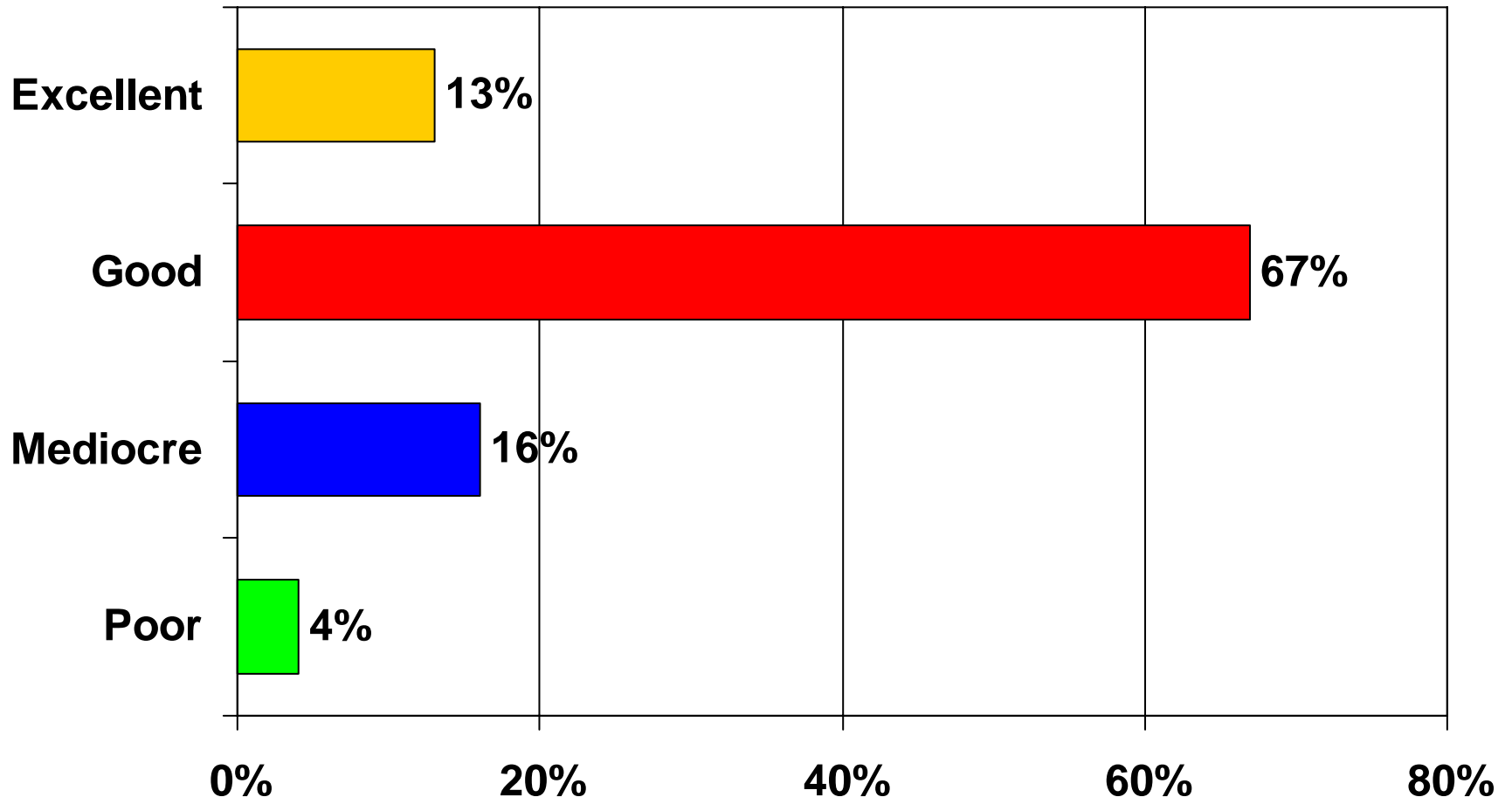
“Z” Visa and “Green Card” / Citizenship



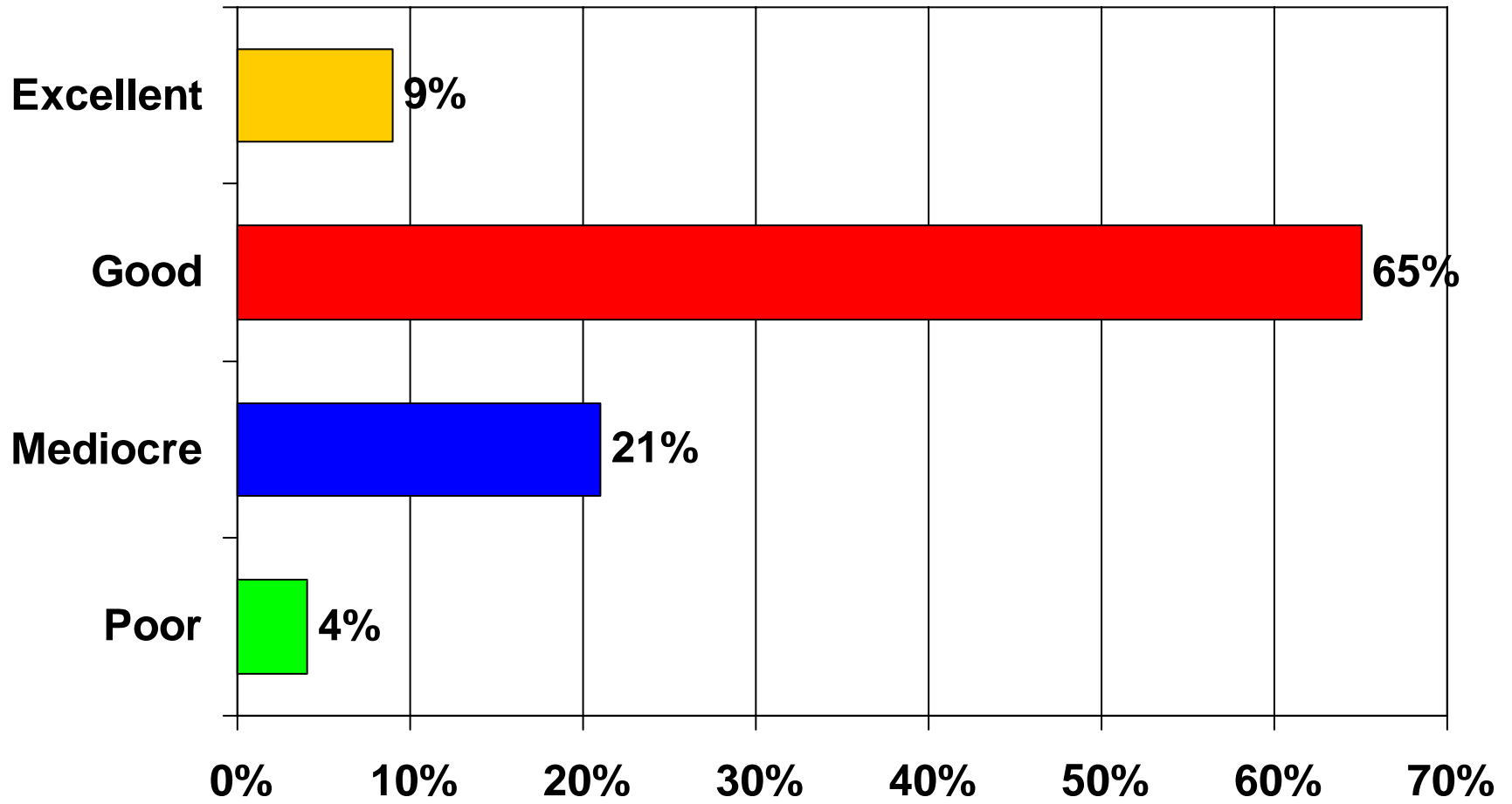
Quality of Life of the Undocumented Latin American Immigrant



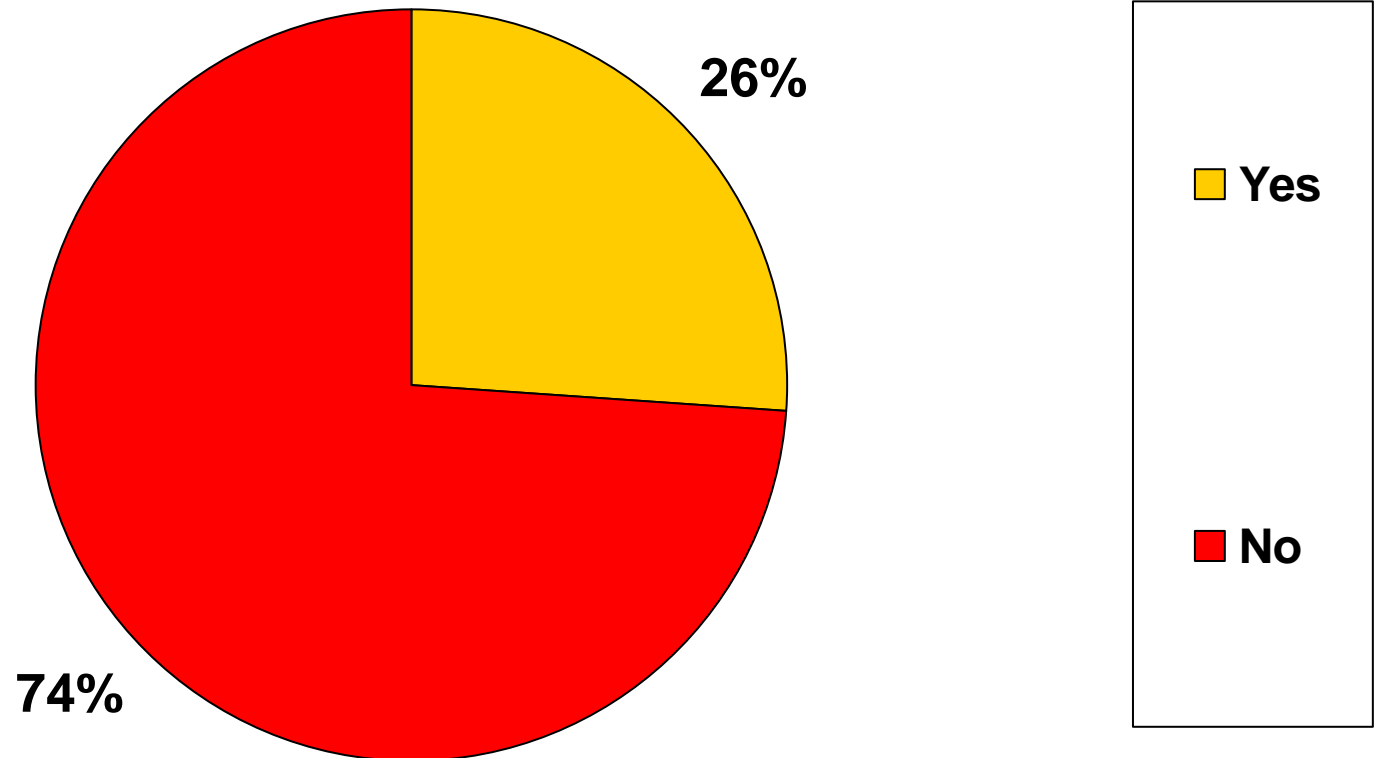
How would you rate the quality of your life in the United States?



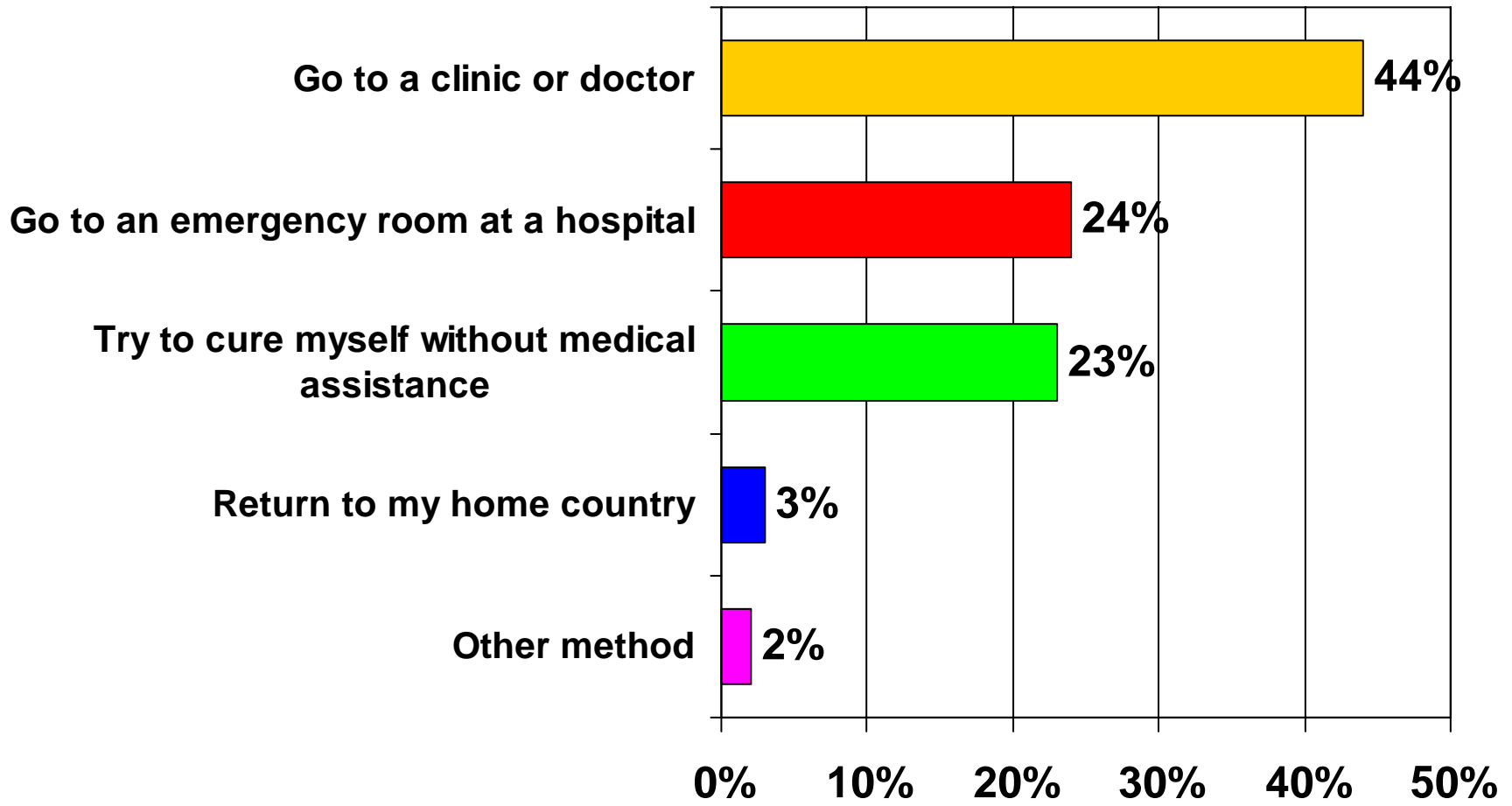
How would you rate the economic situation of your family in the United States?



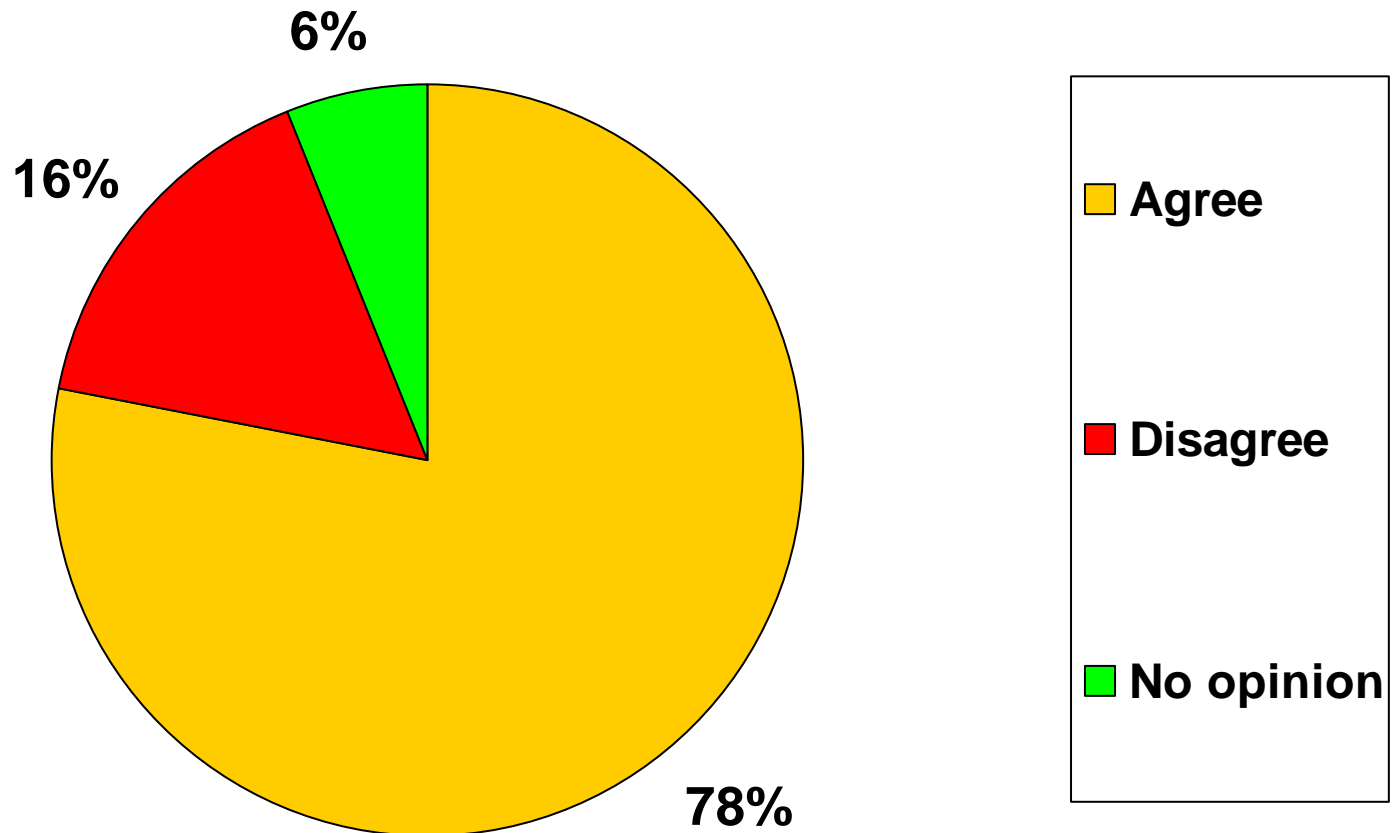
Do you have health insurance?
